When a payer requests your documentation, who makes the rules? How can your clinical documentation be deemed inadequate when it's both correct & thorough?

Payers are more concerned than ever about how your documentation came to exist. In fact, unless you can prove otherwise, payers now assume you may be committing fraud. So they expect your notes to adhere to specific guidelines that prove the content of your notes wasn't created or edited after you received the documentation request.

Most payers adhere to AHIMA (The American Health Information Management Association) guidelines regarding electronic signatures. And most — yes, we speak with them occasionally — are interested in when documentation was created & edited as tracked by your EHR.

The ECLIPSE Encounter now conforms to AHIMA signature guidelines and provides optional audit trails with your submitted documentation -- as directly requested by BC/BS & others when they speak to us. That's just one reason that these payers tell us (and may tell you too if you ask) that they prefer reviewing documentation created in ECLIPSE.

Next, ensure better HIPAA compliance with the newest updates. For the past several years, we've maintained backwards compatibility with Windows XP (after Microsoft ended support). New certified versions of ECLIPSE have shed that yoke and are strictly compatible with current versions of Windows 7 to 10. As a direct result ECLIPSE offers new 3D graphs, better themes that improve readability of Document, Ledger, Encounter & other grids so you can get to data you need faster.

Are your new patients electronically signing forms (e.g. HIPAA consent) using the ECLIPSE KIOSK? Why not? Data can be automatically sent to ECLIPSE across your network and forms imported to the patient's Documents tab.

Thinking about new CMS programs like MIPS? If so, you'll need the newest versions of ECLIPSE to produce reports. And you'll need ECLIPSE to interact with CMS approved registries to earn more incentives.

Updated themes vary lighter/darker background colors across grids to improve readability.








Installation Instructions


